1. Please enter through the **Prim Avenue Entrance** (Graceville Outlet Center)
2. Upon arriving, a Harvest Festival Volunteer will meet you in the Prim Avenue area and direct you to your assigned booth space.
3. Set Up time is 7:00 a.m. Please do not attempt to set up before that time. Please plan for set up of your booth to be completed by 8:30 a.m.
4. When you have completed unloading your vehicle, trailer, etc. Please remove your vehicle from the grounds and park in the McNeil Technology Parking Lot across Prim.
5. If you have an electricity or water space, please be prepared to provide your own electrical cords and or water hoses. We recommend 100 feet.
6. Your booth assignment has been made to best accommodate everyone. Please don't ask to be moved. You will be assigned according to the specifications you requested on your application.
7. Please do not break down until 2:00 p.m. You are welcome to stay as long as the crowd stays. Typically it is feasible to break down between 2:30 and 3:00 p.m.
8. It is highly recommended that you bring a tent for shade and the protection of your product.

**Our Rain-Out Policy:**

If you set up while it is raining, then you will not receive a refund. If you set up and then it begins to rain, you may receive a refund up until 9:00 a.m. After 9:00 a.m. there will be no refunds. We will not reschedule this event.
